## **Our impact**

Our care coordination helps families feel more confident and organized in the care of their child. Families develop a stronger partnership with their child's doctors and specialists and stay at the center of decisions about their child's care. Our care coordination also helps families navigate the maze of resources and insurance coverage/benefits more effectively and achieve their child's educational and vocational goals.

## How we help

We partner with families, doctors, schools and others to develop a plan of care that addresses a child's medical, social, behavioral, educational and financial needs. This process is called care coordination and is FREE, regardless of a family's income level. Our care coordination can include:

- Accessing diagnostic tests
- Finding specialized medical care
- Explaining insurance coverage/benefits
- Communicating with doctors, specialists and schools
- Assisting with transportation for appointments
- Connecting families for parent-to-parent support
- Preparing for the transition to adulthood

We can also help pay for eligible medical expenses, such as equipment, therapies, supplies and medical services, when families meet income guidelines.

Who we help

UIC's Division of Specialized Care for Children (DSCC) is a statewide program that serves Illinois families with children who have or are suspected of having a chronic medical condition in one of our 11 eligible impairment categories. Families who care for children and youth who require in-home shift nursing receive support through the Home Care Program.



### Is my child eligible?

Our eligible medical conditions include, but are not limited to:

- Cardiac Impairments
- Cystic Fibrosis
- Eye Impairments (Cataract, Glaucoma, Strabismus)
- External Body Impairments (Cleft Lip and Palate, Craniofacial Anomalies)
- Hearing Impairments
- Hemophilia
- Inborn Errors of Metabolism (Phenylketonuria [PKU])
- Nervous System Impairments (Seizures, Nerve, Brain, Spinal Cord & Cerebral Palsy)
- Orthopedic Impairments
- Speech Impairments (Dysarthria, Vocal Cord Paralysis)
- Urinary System Impairments

If your child's diagnosis is unclear, we can arrange a diagnostic test.
