#### **Mission**



Medically Fragile/ Technology Dependent Waiver Program (Home Care Program)

#### Home Care Program Overview

- ▶ Katie Beckett's Legacy
- ▶ Provides care coordination to children & youth who require skilled in-home nursing.
- ▶ Operated on behalf of the Illinois Department of Healthcare & Family Services (HFS).
- ▶ 1983 DSCC began operating the MFTD waiver
- ➤ 2014 DSCC became the single point of entry for Illinois children in need of in-home skilled shift nursing.

### Home Care Eligibility

#### All general requirements must be met:

- IL resident & IL address (must have a home in which nursing can be provided)
- Trained caregiver in the home
- Ages 0 21

#### Medical eligibility:

- Waiver: meet 50 points on Level of Care Tool (income waived)
- Non-Waiver: Medicaid recipient / does not need to meet 50 points on Level of Care Tool

#### Home Care Eligibility

- ► Must be <u>technology</u> dependent
- ► Must have skilled nursing <u>care</u> need
- ► Activities of daily living important for caregiving issues, but does not count for points on Level of Care
- Even if there is no medical technology, a parent/caregiver always has the option to submit an application if they wish to.

# Home Care Populations: Waiver vs Non-Waiver

#### Medically Fragile Technology Dependent (MFTD) <u>Waiver</u>

- Must have both medical & technology needs.
- Must be less than 21 years of age at the time of enrollment.
- May qualify regardless of parental income.
- Participants enrolled in the waiver prior to their 21st birthday, and still receiving services on their 21st birthday, may stay with Home Care for life. Can re-apply at any time in their life if they were in the waiver on their 21st birthday.

# Home Care Populations: Waiver vs Non-Waiver

#### Non-Waiver

- Must have an identifiable need for in-home shift nursing, although typically less dependent on technology.
- Must be less than 21 years of age.
- Must be eligible for Medicaid.

#### Waiver

- Child must meet 50 pts on LOC
- DOES NOT need to be Medicaid eligible
- Qualifies for 336 respite hours
- Qualifies for additional benefits (waiver services): home/vehicle modification, extermination services, nurse/family training & electrical bill credit
- May not end at age 21
- CANNOT receive services from other waiver programs; i.e. DRS Home Services Program

- Managed by HFS
- Operated by DSCC
- Monthly
   Contact
- Annual Renewal
- Approved Nursing Agencies

#### **Non-Waiver**

- Child DOES NOT meet
   50 pts on LOC
- DOES need to be Medicaid eligible
- DOES NOT qualify for respite or additional benefits beyond Medicaid
- Ends at age 21
- CAN receive services from other waiver programs; i.e. DRS Home Services Program

#### Home Care Populations: Waiver vs Non-Waiver

## Home Care Waiver Services

- Skilled Shift Nursing
- Care Coordination
- Environmental Modifications (ex. electrical modification, accessibility modifications, generator installation, vehicle modification, extermination)
- Respite
- Specialized Medical Supplies and Equipment
- Training of Nursing Personnel and Families

## Home Care Enrollment Process

- Case assigned to Enrollment Specialist, who will call within 1-2 business days of assignment
- Items/tasks needed for application to be submitted to HFS for review:
  - Signatures from Guardian on initial application paperwork (including authorizations to release health information)
  - ► Home Visit/Home & Community Assessment
  - Medical records from the past year (or from birth present for infants)
  - ▶ Letter of medical necessity written/signed by MD or APN
  - Completion of Comprehensive Assessment
  - Medicaid application for those who do not already have Medicaid in place
  - For children who are hospitalized, the following need to be in place to be able to submit: discharge date/timeline, medical stability, completion of caregiver training.

- Once application submitted to HFS, they will review and provide final decision.
- Non-Waiver applications: approval or denial will be provided
- Waiver applications: HFS will send nursing allocation to Enrollment Specialist, who will call guardian to inform, discuss next steps
- Case will be transferred to ongoing Care Coordination team, who will work with the family on a long-term basis and help to get nursing (or other waiver benefits) in place.


